

What MCM Does...

The **Annual MCM Convention** is held in early autumn and brings together over 250 carrier and supplier members for education, networking, and socializing. The trade show provides members with an opportunity to discuss new technology, products, and services with allied members and can provide many members with new ideas to add value to their business. The seminars provide valuable knowledge about recent changes in the industry. The Golf Scramble is an important chance to join colleagues for a day on the links, relaxing and strengthening important business ties.

The #1 priority of the MCM is to promote safety in the industry. **The Safety Management, Maintenance, & Technology Council** meets every other month to help meet that goal. The council provides members an update on DOT changes and a forum to discuss issues of importance. Annual dues for SMMTC Membership are \$40. SMMTC hosts the **Truck Driving Championship**, held in each June in Billings. They also maintain the **MCM Safety Trailer**, a safety display on wheels. It travels to fairs, schools, and scales.

MCM publishes an **Annual Directory** of all members. This resource provides members with a single, user-friendly guide to the MCM. **The Allied Directory** is frequently printed in the newsletter, providing carriers an up-to-date listing of the suppliers they rely on for their business.
